Payment Terms Conditions

Both parties whose signature's are recorded below agree to be bound by the herein stated terms, information and conditions as stated in this contract. **First:** Upon signing this contract Client will remit payment of \$50.00 within 10 business days unless otherwise agreed upon. Checks returned are subject to a \$25.00 returned check fee plus any bank fees. **Second:** Entertainment agrees to supply sound system, pre-recorded music, DJ/KJ/MC talent, and if herein noted special effects lighting at the time and place listed. **Third:** Entertainment reserves the right to substitute talent at it's discretion when necessary unless otherwise noted. **Forth:** Client will arrange to provide Entertainment with 2-six/eight foot tables, 2-chairs, 2-reliable grounded 110/120V electrical outlets within 15 feet of performance area and ample set-up/equipment space for system(s). Outdoor events require overhead waterproof protection and electricity. For safety & security Entertainment reserves the right to limit guests or agents access to setup area, equipment, or music at any time. **Fifth:** Client agrees to insure safety of Entertainment and allows Entertainment the option to terminate performance at anytime if in Entertainments opinion: guests or agents interfere, impede, or disrupt performance. In this instance, Client shall pay the entire amount due regardless of length of performance time. Client also agrees to be held liable for any damage or theft to/of Entertainments equipment, music, and/or personal property by Clients: Guests, Agents, or event location Staff. **Sixth:** Entertainment is not responsible for circumstances, events, or delays beyond our control such as, but not limited to: acts of God, illness, death, emergencies, delays, mechanical problems associated with music, equipment or vehicle. Entertainment reserves the right to stop performance if operating conditions become detrimental to talent or equipment such as, but not limited to: electrical problems, storms, smoke, fire, rain, water, etc. In these instances, and/or in the unlikely event of equipment failure the total amount due will be pro-rated based on the amount of service provided. Absolutely no other monies will be exchanged as a result. **Seventh:** Should client cancel event for any reason the following charges apply: Booking deposit is non-refundable once received. 90 days prior to performance date - 50% of amount of performance fee agreed upon is due, 60 days prior - 75%, and 30 days prior - 100% **Eighth:** In the event of legal dispute, Client agrees to have matter litigated and subjected to the laws of Entertainments home County & State. Prevailing parties damages or award will be limited to the amount of performance price agreed upon - no other monies will be exchanged. **Ninth:** Client grants Entertainment permission and unconditional release to use any pictures, names, and/or video for promotional and marketing efforts. **Tenth:** Clients warrants that venue has all required permits, insurance, and/or licences, and that Entertainment is not responsible for same. Access to event location is required for setup and breakdown at least 1 1/2 hours prior to start time and after end time, (2 1/2 hours for larger systems). **Eleventh:** Our performance/written material is the property of CSE, and may not be copied, video taped, or recorded without permission.
